Informative to go abroad and return to Italy

Based on the specific information about the business trip provided by the company, Studio A&P will draft a detailed informative with all the necessary requirements to comply with. Said informative is thoroughly prepared based on the foreign and Italian regulations, including even further requirements for transits through third Countries.

Exemption from Quarantine obligations

Upon specific request, the Ministry of Health can grant the exemption to quarantine requirements when returning to Italy, so that employees can physically come back to work while complying with the specific protocol issued by the Ministry. Our office will file the request on behalf of the applicant directly to the Ministry, preparing all the necessary documents and keeping contacts with the offices in charge.

Notification of entry to Italy from abroad

To further help workers coming to Italy from abroad, Studio A&P will also notify the Local Health Office in charge in the territory about the return of the employee, in line with the regulations in force and current health procedures, keeping contacts with the relevant authorities on behalf of the employee.

Green Pass for vaccinations taken abroad

For those who got vaccinated in Extra-EU Countries with vaccines approved by EMA, Studio A&P offer full support in filing the request of the European Green Pass to the Ministry of Health. Our consultants will gather all the necessary documents and keep constant contacts with the relevant ministerial offices.



Covid-19 Tests Reservation

After receiving the required information and preferences from the employee, Studio A&P will directly reserve a molecular or antigenic swab test at laboratories, pharmacies or authorized facilities on national territory and/or abroad, in line with the active regulations and necessary health procedures.

Risk Assessment - Countries at risk

When employees go abroad to carry out work activities, the employer shall guarantee working standards as close as to those of the home country. However, unexpected circumstances may hinder the business trip. For this reason, it is of fundamental importance to thoroughly analyze all the risks that a trip may involve. Following a deep analysis of national and international institutional resources, A&P will draft a detailed report with an overall evaluation from legal consultants and security experts.
