# MOG 231 – Travel Security Section by Studio A&P

Over the last few years, Italian companies have adopted an Organisational and Management Model pursuant to the D.Lgs 231/2001, the so-called MOG 231. In view of departure and stay of its employees in the Foreign Country, the company has to guarantee the most favourable working conditions regarding safety in the destination Country.

## What is the MOG 231?

---

It is an organisational and management model with internal rules and procedures that aim for the company to minimize the probability of committing crimes that may involve the **top managers of the company and the persons dealing with safety inside the company.**

From such crimes, criminal and property liabilities may result.

## MOG 231 – Travel Security Section for posting abroad

---

Nowadays many companies regularly work abroad without having implemented in their 231 model an **ad hoc Section for business routes** which can protect them in court, in the event of an injury and/or an accident occurred in a foreign Country.

With the support of Studio A&P there are two possibilities:

- **MOG 231 ALREADY ADOPTED BY THE COMPANY:** it is possible to create a **Special Section for posting abroad** to be implemented in your own 231 Model with specific company rules and procedures;
- **MOG 231 NOT ADOPTED:** it is recommended that the company develops a **Travel Security Procedure** for posting abroad so that it can prevent the risk of committing crimes related to working activities performed outside the Italian territory.



# The Risk Assessment Software of Studio A&P

The “Risk Assessment” software is available online on our dedicated platform and allows the company to implement the measures suggested by the Special Section for every single business route.

The software is based on 6 reliable foreign government sources to create the interactive risk Maps which allow the company to geolocate its site.

## Levels of Risk

---

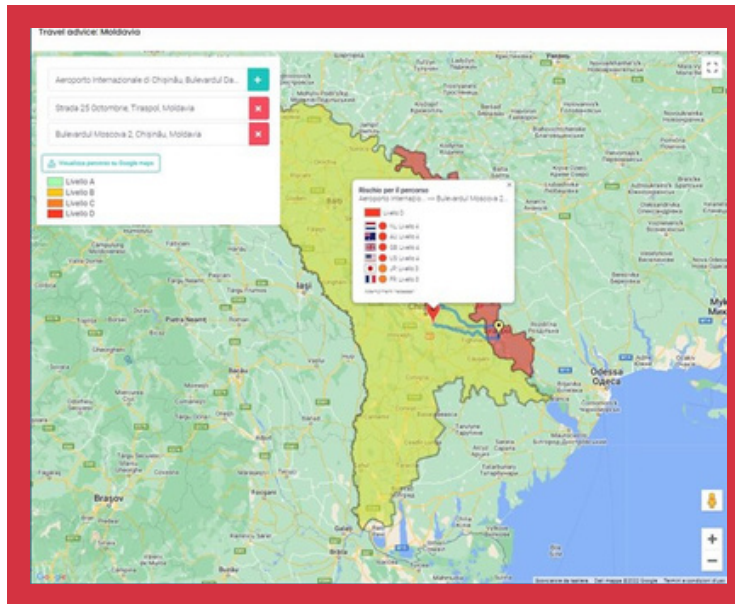
According to the software's risk assessment, the company can implement the most appropriate measures to organise a safe business route conforming to the **increasing levels of risk**, in particular:

- **LEVEL A - Low risk area:** Studio A&P provides the company with a free and in-depth pre-departure analysis of all necessary measures for the business route (e.g. immigration, contribution, health, and insurance aspects) by verifying and preventing possible risks in the foreign site with regard to Italian L. Decree 81/2008;
- **LEVEL B – Medium risk area:** Studio A&P provides a detailed geopolitical assessment of the Country of destination based on 6 reliable foreign government sources and organised in 6 subject areas which are constantly monitored (security, crime level, political stability, infrastructure, risk of terrorist attacks, local customs and laws, healthcare, natural disasters, general travel advice abroad);



- **LEVEL C – High risk area:** Studio A&P creates and provides the company with an Operative Plan with all the obligations that both the company and employees on business route must fulfill;
- **LEVEL D – Very high risk area:** Studio A&P creates and provides Emergency Plans which take into account the risks related to health and safety aspects on the workplace abroad.

## Features of the Online Software A&P
